Disbandment of Headquarters, First US Army Group - - - - - I
Military Justice - - - - - II

I--DISBANDMENT OF HEADQUARTERS, FIRST US ARMY GROUP. 1. Headquarters, First US Army Group, activated by General Orders No. 74, this headquarters, 16 October 1943, is disbanded, effective this date.
2. All units assigned and/or attached to Headquarters, First US Army Group, are relieved of such assignment and/or attachment and are assigned and/or attached to Twelfth Army Group. (AG 322 OpGC)

II--MILITARY JUSTICE. The Commanding General, Seine Section, Communications Zone, is authorized to exercise command authority for the discipline and the administration of punishment, under Article of War 104 and by trial and punishment by Summary, Special or General Courts-Martial, over personnel of this command committing offenses within the geographical limits of such Section; except over such personnel and in such areas as may be expressly excepted from the jurisdiction here granted. Personnel on duty at headquarters superior to Headquarters, Seine Section, will not be detailed in any capacity by the Commanding General, Seine Section, Communications Zone, on courts-martial or courts inquiry without specific authority therefor from the headquarters concerned.
